NOTIFICATION FOR RENEWAL OF AFFILIATION 2026-27

It is notified for information of all the concerned that the Private Institutions (Schools/Colleges) within the jurisdiction of BISE Abbottabad are required to renew their affiliation for the session **2026-27**, latest by **30-09-2026**. **Late fee @ Rs. 50/- per day for late submission of renewal fee after 30-09-2026** will be charged. The following requirements are mandatory to be fulfilled in this regard.

1. Registration letter issued by Private Schools Regulatory Authority (PSRA), for the session 2025-26 (Earlier Notified by PSRA No. KP-PSRA/AD-II//Coord./2026-2027 dated 18-06-2026) is a pre-requisite for the purpose of renewal of affiliation. No institution will be affiliated without provision of Registration letter for the session 2025-26 by PSRA.
2. The grant of affiliation to the institutions will be subject to ensuring the fulfillment of the prescribed formalities such as Building, Teaching Staff, Laboratory and Exam Hall etc.
3. The form for renewal of affiliation is available on official website of BISE Abbottabad (www.biseatd.edu.pk). The renewal form, PSRA letter for 2025-26 & deposit receipt of prescribed renewal fee be submitted in Academic Section BISE Abbottabad after online enrollment of students.
4. The institutions who have not yet deposited the renewal fee of any of the previous years, must also deposit the same.
5. In case of change of ownership of institution, the prescribed fee of Rs. 20,000/- is to be deposited, along with a copy of letter issued by PSRA for change of ownership. In case of change in name of institution, fee of Rs. 10,000/- is to be deposited along with a copy of letter issued by PSRA for change in name of institution.

7. Renewal fee for Private institution is to be deposited online or in any branch of Allied Bank.
